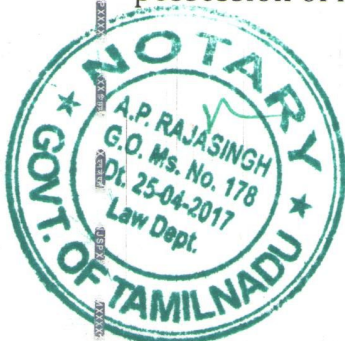

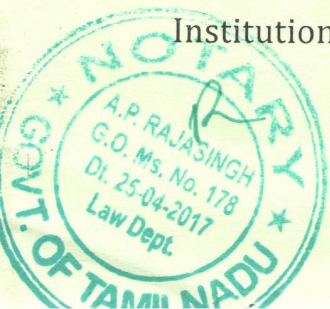

7. That the copy of the affidavit shall be displayed on the website of the Institution for general public.




